All applications, accompanied by your Tax Assessment for the preceding year, must be received at College by <u>Friday 3<sup>rd</sup> March 2023</u> at the latest. Late applications will not be considered.

If applications are successful, parents must complete assessment forms on an annual basis to show the latest financial position.

## The Dome Charitable Trust

This Scholarship will be available to an able student whose parents, without financial assistance, would not be able to send their daughter to the College. The student must show a high degree of both ability and motivation, as well as the right attitude towards learning, to take advantage of the educational opportunities offered by Jersey College for Girls.

If a suitable candidate is found each year, the Trustees will award a Scholarship and this will cover the period until the year in which she becomes eighteen, subject to continued motivation and the parents' financial circumstances being similar to those when the scholarship was awarded.
